## [LATEST] HEIGHTENED ALERT IN THE FIGHT AGAINST COVID-19

On 30 April and 4 May 2021, MOH announced tightened community measures to reduce the risk of community transmissions, following new clusters of infection. Key updates to safe management measures (SMMs) for arts and culture stakeholders are summarised below, with further details in the respective sections. ### **Updates to Group Sizes for Arts and Culture Activities and Live Performances**

From 8 May through 30 May 2021, group sizes are limited to no more than 5 persons. This will apply to all arts and culture activities, including classes, lectures, talks and workshops, as well as live performances. This has been reflected in the respective sections.

### **Updates for Live Performances**

**All indoor and outdoor live performances should be deferred, unless these have been announced and publicised before 5 May 2021. Live performances which have been publicised before 5 May 2021 and which are scheduled to take place from 8 May through 30 May 2021 may only proceed with approval from MTI, and with audiences capped at 100 pax (without pre-event testing) or 250 pax (with pre-event testing).**

To seek approval to proceed for indoor and outdoor live performances which have been publicised before 5 May 2021, and which are scheduled to take place from 8 May through 30 May 2021, please submit the application form found in the ‘Resumption of Live Performances’ section, to NAC and STB.

**There should be no announcement, publicity or ticket sale for live performances which have not already been publicised, until further notice.**

From 8 May through 30 May 2021, singing by masked performers on stage will only be permitted, if the total number of masked and unmasked singers is no more than 5 at any given time.

### **Updates for Dance Classes**

From 8 May through 30 May 2021, all dance classes are required to adhere to the tightened SMMs that have been updated in the ‘Arts and Culture Classes, Lectures, Talks and Workshops’ section.

### **TraceTogether only SafeEntry Implementation and SafeEntry Gateway**

TraceTogether (TT) only SafeEntry, where the TraceTogether App or Token is required for SafeEntry check-ins, will be rolled out nationally on 17 May 2021. In preparation, art and culture premises are to ensure that they are able to accept TT Tokens for SafeEntry check-in at their venues as soon as possible if not already done. Once TT only SafeEntry is implemented, venue operators should allow

only individuals who have successfully checked into SafeEntry using their TT App or TT Token to enter the venues.

SafeEntry Gateway will be deployed as an additional mode of SafeEntry check-in to more public-facing venues where people are likely to be in contact for prolonged periods, in order to facilitate a more seamless check-in experience and to ensure that TT Tokens are working. These venues will be required to deploy the SafeEntry Gateway by 15 June 2021. ### **Venue Hire Subsidy**

The Ministry of Culture, Community and Youth has extended its existing 80% subsidy for venue hire and in-house production costs (where applicable) until 30 June 2021, and will review any potential further extensions. This subsidy will be for arts and culture activities permitted to resume at venues in the Esplanade, National Gallery Singapore, National Heritage Board museums and heritage institutions, STPI Creative Workshop & Gallery, Singapore Chinese Cultural Centre, Singapore Conference Hall, as well as those managed by Arts House Limited. It has also been extended to select arts centres with shared facilities under NAC. Please contact participating organisations directly for details.

### **Towards a Safe and Sustainable Reopening**

NAC will deploy Safe Distancing Ambassadors (SDAs) to perform scheduled inspections at arts and cultural premises, to encourage compliance to SMMs. Arts and culture companies and practitioners who do not implement or comply with requirements may be closed down, ineligible for government grants and assistance, and subject to penalties under the COVID-19 (Temporary Measures) Act 2020. Additional penalties may be imposed on arts and culture stakeholders whose premises are found to have been a place of transmission of COVID-19, if they have not adhered to these requirements.

NAC will continue to work with arts and culture stakeholders, and relevant Government agencies, to expand and restart activities so that our arts practitioners can continue their good work. Further updates on the provisions and SMMs for these activities will be published here when available.

A safe and sustainable re-opening requires all of us to play our part. It is critical that we continue to exercise caution, adhere to SMMs, and practise social responsibility. Collectively, we can progressively re-open our economy and society while remaining safe.

<b>[UPDATED] RESUMPTION OF LIVE PERFORMANCES</b>

First issued on 20 October 2020

Updated on 5 May 2021

1. All indoor and outdoor live performances should be deferred, unless these have been announced and publicised before 5 May 2021. Live performances which have been publicised before 5 May 2021 and which are scheduled to take place 8 May through 30 May 2021 may only

proceed with approval from MTI, and with audiences capped at 100 pax (without pre-event testing) or 250 pax (with pre-event testing).

2. There should be no announcement, publicity or ticket sale for live performances which have not already been publicised, until further notice.
3. This section sets out the SMMs that must be observed for live performances, including (i) which venues are permitted; (ii) limits on the number of production crew and performers who can be unmasked; and (iii) safe distancing on stage, backstage, between the performers, and among the audience.

#### **Application to proceed for live performances publicised before 5 May 2021**

4. Arts and culture organisations may submit an application to [NAC\\_Feedback@nac.gov.sg](mailto:NAC_Feedback@nac.gov.sg) for NAC's assessment. Event organisers of conventions, tradeshows, concerts and other events may submit their applications to [leisureevents@stb.gov.sg](mailto:leisureevents@stb.gov.sg) for STB's assessment. The application form can be found at [Annex A](#) and must be completed in full.
5. Applicants must also submit an event proposal together with their application. The event proposal should comply with and include the SMMs that would be implemented to ensure the following outcomes required for piloting live performances in a safe and controlled manner (also indicated at Section E of the application form):
  - Limit overall density and movement of audience members;
  - Limit opportunities for and number of close contacts between individuals; and
  - Ensure a safe and clean environment for employees and attendees.
6. For applications that are approved, MTI will authorise the applicant to carry out the live performance, indicating the SMMs that will need to be adhered to.
7. While the majority of the SMMs in the application form are drawn from the COVID-19 (Temporary Measures) (Control Order) Regulations 2020 and COVID-19 (Temporary Measures) (Performances and Other Activities – Control Order) Regulations 2020 (collectively "Control Orders") and are summarised for convenience, these SMMs are not exhaustive and the prevailing Control Orders will take precedence in case of any inconsistency.

#### **Safe Management Measures (SMMs)**

8. The SMMs for live performances are at Annex B. They have been developed with arts and culture stakeholders to ensure the safety of our performers, crews and audiences. They also take into account the learning points and feedback from the live performance pilots, which demonstrated how live performances could be staged safely with appropriate SMMs.
9. All persons entering live performance venues are required to check in to SafeEntry through either scanning the QR code using the TraceTogether App on their phone, or by presenting their TraceTogether Token to be scanned. Other check-in modes, such as using the phone's camera, SingPass Mobile, other QR code reader apps, or using NRIC/FIN and other photo IDs, will not be accepted. The widespread use of TraceTogether in these venues will allow quicker contact tracing and ringfencing of any infections.

## Venues

10. The following pre-selected venues may host indoor live performances:

11. Venue owners/managers should log onto MTI's [Go Business portal](#) from 1 November 2020 with your CorpPass to confirm that you are permitted to host an indoor live performance.

Venue owners/managers may approach their respective sector lead agencies if they have any queries on the conduct of live performances in their spaces. Venue owners/managers that have not been identified as permitted venues may apply to their respective sector lead agencies - via the emails indicated above - or through the MTI [Go Business portal](#).

12. Marriage solemnisations (in indoor venues only), funerals and funerary-related activities may also involve live instrumental music (non-wind only) with the necessary SMMs in place. No other performances (e.g. singing, dance, variety act) are allowed. Please refer to the MCCY advisory on "[Moving into Phase Three of Re-opening for Religious Activities](#)" for these SMMs.

13. Live performances are currently not allowed to resume in food and beverage establishments and wedding receptions regardless of venue, as there is a higher likelihood of mingling, talking, where food is being consumed with patrons who are unmasked. Higher risk activities such as singing and the playing of wind/brass instruments are also not allowed to resume at corporate/enterprise events (e.g. product launches).

## Required Safe Management Measures for Live Performances and Related Rehearsals

<b>General</b>	<ul style="list-style-type: none"><li>• Live performances which have been publicised before 5 May 2021 and which are scheduled to take place from 8 May through 30 May 2021 may only proceed with approval from MTI. If no pre-event testing (PET) is conducted, restrict audience size to a maximum of 100 persons. If pre-event testing (PET) is conducted, restrict audience size to a maximum of 250 persons.<ul style="list-style-type: none"><li>○ PET must be done before entry to live performance and at most 24 hours before the end of the live performance.</li><li>○ Organisers must ensure that the audience members have a valid negative test result, or are exempted from PET, before allowing them into the live performance venue. MOH will be releasing further information and tools to support the implementation of PET, which will be made available at <a href="https://go.gov.sg/pet">https://go.gov.sg/pet</a> when ready.</li></ul></li><li>• Audiences are to comprise no more than 5 persons per group, in line with national guidelines on group size.<ul style="list-style-type: none"><li>○ There should be no physical interaction or mixing between groups.</li></ul></li><li>• Adopt seating arrangements to ensure 1m safe distance between groups of up to 5 all around.</li><li>• Audience members should be masked.</li><li>• Audiences are to remain static and not move around the venue during the performance.<ul style="list-style-type: none"><li>○ While audiences may move from set to set (or point to point) in their groups in-between live performance segments, there are to remain stationary during a live performance.</li><li>○ <b>No audience participation in a live performance.</b></li></ul></li><li>• No physical interactions between audiences and performers (e.g. autograph/photograph sessions, inviting members of the audience on stage).</li><li>• A safe distance of 3m is to be maintained between audiences and performers at all times.<ul style="list-style-type: none"><li>○ Venues without a clearly defined stage area should have floor markings to mark out the 3m safe distance between performers and audience and ensure that the safe distance is observed.</li><li>○ If the live performance is taking place on a stage which places performers at a higher vantage point, a safe distance of more than 3m is encouraged, due to the trajectory of droplet projection.</li></ul></li></ul>

- Audiences are encouraged to make online ticket purchases and use e-payment methods.
- No intermissions and pre/post-performance receptions, in order to reduce congregations of people and audience mingling.
- Venues are required to implement TraceTogether-only Safe Entry ([please click here for the Safe Entry User Guide](#)) to collect personal details (including identification numbers and mobile numbers) and manage the entry of all persons (including staff, visitors and patrons) into the live performance space.
  - SafeEntry check-ins can only be completed by either using their TT App to scan the venue's QR code or presenting the QR codes printed on their TT tokens to be scanned by the venue (in the same way NRIC/FIN/other IDs are now scanned for entry).
  - Other check-in modes, such as using phone's camera, SingPass Mobile or other QR code reader apps, or using NRIC/FIN and other photo IDs, may not be accepted.
- Venues are encouraged to deploy implement SafeEntry Gateway before 15 Jun 2021 to facilitate a more seamless check-in experience and ensure that TT tokens are functioning. (SafeEntry Gateway will be required from 15 Jun 2021.)
- Queue lines for audiences should be clearly demarcated at the entrance to performance venues and box offices to ensure 1m spacing between groups.
- Sale of merchandise is allowed as long as safe distance of at least 1m is maintained between groups.
- Sale of F&B is allowed, but consumption of F&B is prohibited in the same space as the live performance, during the period of the live performance. Venues must also abide by the [Enterprise Singapore guidelines](#) on sale and consumption of F&B.
- For venues with multiple performance spaces:
  - There should be no sharing of common facilities, including restrooms, between performers/crew and audience members as a best practice. If this is not possible, the use of common spaces should be staggered.
  - Deconflict performances' start and end timings to prevent congregations at public spaces/taxi stands. If possible, have separate ingress/egress for audiences attending different performances to avoid crowding within the venue.
- Venue staff to be on-site to ensure compliance to safe distancing measures and minimise/prevent congregations of audience members, including at ticket collection points, entry to the performance space, and within the performance space itself.

	<ul style="list-style-type: none"> <li>• Visible signs/posters on social distancing measures are to be put up strategically at entrances and within the building as reminders for members of the public. These include wearing masks, maintaining safe distance, and to not enter the venue if unwell.</li> <li>• To abide by <a href="#">SG Clean guidelines</a> for sanitisation and hygiene standards.</li> </ul>

**[UPDATED] DIGITAL PRODUCTIONS FOR ARTS AND CULTURE STAKEHOLDERS**

First issued on 21 June 2020

Updated on 5 May 2021

1. On 19 June 2020, the National Arts Council (NAC) issued an advisory on “Phase Two of Re-Opening for Arts and Culture Stakeholders”, which noted that there would be further adjustments to what is allowed for digital productions and rehearsals in Phase Two. NAC would like to provide further information on the provisions for these activities, and the required safe management measures for them to proceed.

**Digital Productions**

2. **From 22 June 2020, all arts and culture premises may be used by arts and culture companies and practitioners for digital productions and recording of courses and performances.** The safe management measures detailed here apply to rehearsals related to these digital productions as well. Arts and culture stakeholders who would like to use and/or rent out their premises for these activities must adhere to the following requirements:

- A maximum of 30 performers and crew are allowed on stage and backstage at any given time.
- This includes a maximum of 10 performers who can be unmasked at any given time.
- **Of the 10 unmasked performers, no more than 5 performers may sing at any given time. Singing by masked performers is only permitted, if the total number of masked and unmasked singers is no more than 5 at any given time.**
- Maintain at least 1m safe distance between performers, including those remaining masked, as a general rule, although transient contact between performers during a performance is acceptable. Additionally:
  - i. All unmasked performers that are engaging in higher risk activity (singing, playing of

wind/brass instruments) should maintain at least 2m safe distance from others.

ii. As a best practice, singers should try not to position themselves directly opposite each other and are encouraged to sing away from each other. If they cannot do so, they should maintain more than 2m distance apart from each other.

iii. Individuals playing wind or brass instruments should ensure that these instruments are fully intact, and refrain from training practices involving only parts of the instrument (e.g. mouthpiece buzzing, playing with just the lead pipe) to prevent droplet transmission. Liquids from instruments (i.e. condensation and saliva) should be collected and disposed of hygienically after the rehearsal or concert.

- Sharing of all other equipment (e.g. props, musical instruments and microphones) should be avoided as far as possible. If this cannot be done, the equipment should be thoroughly cleaned and/or disinfected before handled or used by others.
  - Venues should be as well-ventilated as possible.
3. Special provisions have been made for digital productions programmed and/or commissioned by NAC, Esplanade, Singapore Symphony Orchestra, Singapore Chinese Orchestra, and the Singapore Chinese Cultural Centre to involve no more than 50 persons (performers and crew), with no more than 20 performers unmasked at any given time. Arts and culture companies and practitioners involved in these commissioned and/or programmed work will also be subject to these limits. This reflects these organisations' role in the development of Singapore's arts and culture sector, as national cultural institutions and companies. Notwithstanding, productions with "live" singing must not have more than 30 persons (performers and crew) involved, with no more than 10 performers unmasked at any given time. Of the 10 unmasked performers, no more than 5 performers may sing at any given time.

### **Venue Requirements**

4. The owners/managers of all arts and culture premises which re-open for the above-mentioned activities are to ensure the following:
- Implement visitor registration and contact-tracing measures via SafeEntry or Trace Together- only SafeEntry. Encourage visitors to install and use TraceTogether.
  - Put in place temperature screening measures. Persons who are unwell should be turned away and encouraged to seek medical attention.
  - Adopt SG Clean standards as new norm for sanitisation and hygiene standards:
    - i. Adhere to sanitation and hygiene advisories disseminated by the National Environment Agency;
    - ii. Provide cleaning agents at all toilet and hand-wash stations;
    - iii. Provide disinfecting agents at all human traffic stoppage points within venue;
    - iv. Regular cleaning of common and high-touch surfaces (e.g. handrails, handles/knobs).
  - Put up notices to remind visitors and employees of prevailing safe management measure, practice social responsibility and encourage the observance of social norms such as:

- i. Observe good personal hygiene (e.g. regular hand washing, refrain from touching face);
  - ii. Avoid handshakes and greet with a smile;
  - iii. Avoid speaking loudly to reduce risk of transmission through droplets.
5. Arts and culture premises located in tenanted spaces (e.g. commercial malls) must comply with the requirements above, as well as any other requirements that the Government may impose through landlords on tenants. Arts and culture companies and practitioners who are also landlords must ensure their tenants comply with any such requirements.

## [UPDATED] ARTS AND CULTURE CLASSES, LECTURES, TALKS AND WORKSHOPS

First issued on 19 June 2020

Updated on 5 & 8 May 2021

### **Training classes and professional workshops**

Training classes and professional workshops, except for classes in dance, singing, voice training, speech and drama, wind and brass instruments, must adhere to the following requirements before they resume:

- Limit group size to no more than five participants (excluding one instructor).
- More than one group of five may be permitted in the same room, as long as there is:
  1. At least 1 metre spacing between all groups;
  2. No physical interaction or intermingling between different groups;
  3. No more than 50 persons in a single room
- Masks should be worn as a default, except for instructors who may wear face shields only if teaching, and if remaining seated or standing generally in a fixed position at least 1 metre from others. If the class, lecture, talk or workshop involves performers for demonstration purposes, the performers will be subject to the live performance SMMs for those segments. When not performing (i.e. when the speaker/instructor is speaking), the performers will need to be masked even if they remain on stage.
- Sharing of all other equipment (e.g. props, musical instruments and microphones) should be avoided as far as possible. If this cannot be done, the equipment should be thoroughly cleaned and/or disinfected before handled or used by others.
- All surfaces are to be thoroughly cleaned and/or disinfected between classes and workshops.
- Venues should be as well-ventilated as possible.

### **Classes in Dance**

From 8 May through 30 May 2021, all indoor dance classes must adhere to the following requirements:

- Limit class size to no more than a maximum of 30 persons (including the instructor), subject to the total capacity that the venue can accommodate with safe distancing;
- Limit group size to no more than 5 persons;
- All persons must be properly masked at all times, including when performing the dance activity;
- There must be a minimum of 2 metres safe distance between persons;
- There must be a minimum of 3 metres spacing between each group;
- There should be no provision of common equipment. Participants should also avoid sharing equipment;
- Participants, including the instructor, must not talk loudly, sing, or shout while engaging in physical activities to minimise risk of transmission via droplets;
- There must be a minimum of 15 minutes interval between class start times, if a premise is able to host multiple classes at a time. Alternatively, the premise must put in place separate routes to prevent intermingling and mixing between participants of different classes before and after class;
- The classroom should be ventilated after the end of each class;
- Participants should leave the premises immediately once they have completed their class, or if they have exceeded a two hour period;
- The premise should be wiped down / sanitised frequently; and
- No food and drink is to be supplied or consumed within the activity area to ensure masks remain on (apart from bottled water)

Only low intensity activities where all participants and instructors are wearing masks at all times may continue. Indoor dance classes must be suspended if they are not able to adhere to the above requirements.

Outdoor dance classes can proceed from 8 May through 30 May 2021, as long as they are conducted in line with the requirements at SportSG's "[Stricter Safe Management Measures for Sport and Physical Exercise & Activity \(8 to 30 May\)](#)".

### **Classes in singing, voice training, speech and drama, wind and brass instrument**

First issued on 3 August 2020

Updated on 5 May 2021

Singing, voice training, speech and drama, and wind and brass instrument classes have been allowed to resume from 3 August 2020, under controlled conditions because these activities pose a higher risk of virus transmission. From 5 April 2021, the capacity for these classes will be increased in alignment with similar settings such as digital productions and rehearsals:

- Classes involving singing, voice training, speech and drama, and wind and brass instruments may have up to **30 participants in a class (including instructor(s) and accompanists(s)), with only the same group of 10 participants allowed to unmasked throughout;** and
- **If singing is conducted during the class, only the same 5 fixed singers may be unmasked and sing throughout.** Masked singing by the other participants is not allowed.

The organisers of these classes must ensure that they adhere to the SMMs detailed in the Annex.

### Safe Management Measures for Higher Risk Classes

### EASING OF SMMS FOR ARTS AND CULTURE STAKEHOLDERS IN PHASE 3

On 24 March 2021, the Ministry of Health (MOH) announced that Singapore will be expanding our vaccination programme, and as we vaccinate more of our population, more economic and community activities will be allowed to resume. Key updates to safe management measures (SMMs) for arts and culture stakeholders are summarised below, with further details in the respective sections of this advisory. #### Updates for Live Performances

From 5 April 2021, singing by performers with masks on will be permitted on stage. However, as per prevailing SMMs, only a maximum of 10 performers are allowed to unmask and of that 10 performers, only maximum of 5 are allowed to sing unmasked at any given time.

From 24 April 2021, **zoning will no longer be required for live performances as long as all other SMMs are adhered to**, including ensuring that: (i) all audience members remain seated and masked throughout the live performance; and (ii) Trace Together (TT)-only Safe Entry (SE) is implemented for all audience members.

From 24 April 2021, **live performances may have up to 750 audience members (with safe distancing) if pre-event testing is implemented. Pre-event testing is not required for live performances with no more than 250 audience members.**

- PET testing must be done before entry to the live performance and at most 24 hours before the end of the live performance. MOH will be releasing further information and tools to support organisers in implementing pre-event testing; this will be made available at <https://go.gov.sg/pet> when ready.
- Individuals who have completed the full vaccination regimen and have had time to develop sufficient protection (i.e. two weeks after the second dose of the Pfizer or Moderna COVID-19 vaccination) are exempted from PET testing ahead of the live performance.

#### Increased Capacity for Arts and Culture Classes and Workshops

From 5 April 2021, the capacity for singing, voice training, speech and drama and wind and brass instrument classes will be increased in alignment with similar settings such as digital productions and

rehearsals:

- Classes involving these activities may have up to **30 pax in a class (including instructor(s) and accompanists(s))**, with **only the same group of 10 pax allowed to unmask throughout**; and
- **If singing is conducted during the class, only the same 5 fixed singers may be unmasked and sing throughout.** Masked singing by the other participants is allowed.
- The total number in the classroom cannot exceed what the room can take with safe distancing. There must be at least 1m safe distance between individuals who are masked. For individuals who are unmasked, they must maintain a 2m safe distance with the next individual.
- *E.g. In a classroom of 26 students for jazz singing lessons with an instructor and accompanists on keyboard, guitar and saxophone, it is permissible for up to 10 fixed individuals in the classroom to be unmasked. Among that 10, there must not be more than 5 fixed individuals singing. Individuals must be 1 m apart if masked, and 2m apart if they are unmasked.*

### **TraceTogether only SafeEntry Implementation**

TraceTogether (TT) only SafeEntry, where the TraceTogether App or Token is required for SafeEntry check-ins, will be rolled out nationally. In preparation, art and culture premises are to ensure that they are able to accept TT Tokens for SafeEntry check-in at their venues as soon as possible if not already done. Once TT only SafeEntry is implemented, venue operators should allow only individuals who have successfully checked into SafeEntry using their TT App or TT Token to enter the venues.

### **Venue Hire Subsidy**

The Ministry of Culture, Community and Youth has extended its existing 80% subsidy for venue hire and in-house production costs (where applicable) until 30 June 2021, and will review any potential further extensions. This subsidy will be for arts and culture activities permitted to resume at venues in the Esplanade, National Gallery Singapore, National Heritage Board museums and heritage institutions, STPI Creative Workshop & Gallery, Singapore Chinese Cultural Centre, Singapore Conference Hall, as well as those managed by Arts House Limited. It has also been extended to select arts centres with shared facilities under NAC. Please contact participating organisations directly for details.

### **Towards a Safe and Sustainable Reopening**

NAC will deploy Safe Distancing Ambassadors (SDAs) to perform scheduled inspections at arts and cultural premises, to encourage compliance to SMMs. Arts and culture companies and practitioners who do not implement or comply with requirements may be closed down, ineligible for government grants and assistance, and subject to penalties under the COVID-19 (Temporary Measures) Act 2020. Additional penalties may be imposed on arts and culture stakeholders whose premises are found to have been a place of transmission of COVID-19, if they have not adhered to these requirements.

NAC will continue to work with arts and culture stakeholders, and relevant Government agencies, to expand and restart activities so that our arts practitioners can continue their good work. Further updates on the provisions and SMMs for these activities will be published here when available.

A safe and sustainable re-opening requires all of us to play our part. It is critical that we continue to exercise caution, adhere to SMMs, and practise social responsibility. Collectively, we can progressively re-open our economy and society while remaining safe.

### PHASE TWO OF RE-OPENING FOR ARTS AND CULTURE STAKEHOLDERS



On 15 June 2020, the Ministry of Health announced that Singapore would move into Phase Two of Re-opening after 18 June 2359 hours, and that further guidance would be provided by relevant agencies for their respective sectors.

[Indoor live performances can resume at permitted venues from 1 November 2020.](#) There will continue to be no performances and events with audiences (“live performances”) for now, as large gatherings of people for a prolonged period of time increases the risk of transmission of the virus. All indoor and outdoor performance venues (e.g. theatres, concert halls, blackboxes) will therefore remain closed to such activities. The National Arts Council (NAC) will continue to engage arts and culture stakeholders on safe management measures that will allow live performances and events to resume in a safe manner for performers and audiences.

**However, there will be a progressive resumption of other activities for arts and culture companies and practitioners in Phase Two, to support continued artmaking, cultivation of audiences, and the professional upgrading of our community. Through this advisory, NAC would like to provide further information on these activities, and the safe management measures which have to be in effect before these activities are permitted to resume.**

Arts and culture organisations should log onto MTI’s [Go Business portal](#) with your CorpPass to confirm the activities you are permitted to resume, and the date of resumption.

### **Workplaces**

Arts and culture premises, including studios for art-making, can be used as workplaces from 19 June 2020, subject to the Ministry of Manpower’s [Requirements for Safe Management Measures at the Workplace](#). Access to the premises should be restricted to employees and authorised visitors only. Arts and culture premises should remain closed as workplaces if they are unable to adhere to MOM’s requirements.

### **Commercial Art Galleries and Non-Profit Exhibition/Gallery Facilities**

Commercial Art Galleries can re-open to the public from 19 June 2020, similar to other retail establishments, subject to Enterprise Singapore’s [safe management measures for retail establishments](#).

Non-Profit Exhibition/Gallery Facilities may also re-open to the public for exhibitions from 26 June 2020, subject to the safe management measures set out in National Heritage Board’s [advisory for museum stakeholders](#). Owners/managers of such facilities are to submit their safe management plan (SMP) to NAC at least three days prior to reopening to the public. However, NAC reserves the right to suspend activities if there are gaps in the SMP submitted or inadequate implementation, until the necessary rectifications are made. If the facility wishes to deviate from the safe management measures indicated in NHB’s advisory, NAC’s explicit approval must first be obtained before facilities can be re-opened.

## **Venue Requirements**

The owners/managers of all arts and culture premises which re-open for the above-mentioned activities are to also ensure the following:

Implement visitor registration and contact tracing measures via SafeEntry. Encourage visitors to install and use TraceTogether.

Obtain visitor health declarations and put in place temperature screening measures. Persons who are unwell should be turned away and encouraged to seek medical attention.

Adopt SG Clean standards as new norm for sanitisation and hygiene standards:

Adhere to sanitation and hygiene advisories disseminated by the National Environment Agency;

Provide cleaning agents at all toilet and hand-wash stations;

Provide disinfecting agents at all human traffic stoppage points within venue;

Regular cleaning of common and high-touch surfaces (e.g. handrails, handles/knobs).

Put up notices to remind visitors and employees of prevailing safe management measures, practice social responsibility and encourage the observance of social norms such as:

Observe good personal hygiene (e.g. regular hand washing, refrain from touching face);

Avoid handshakes and greet with a smile;

Avoid speaking loudly to reduce risk of transmission through droplets.

Arts and culture premises located in tenanted spaces (e.g. commercial malls) must comply with the requirements above, as well as any other requirements that the Government may impose through landlords on tenants. Arts and culture companies and practitioners who are also landlords must ensure their tenants comply with any such requirements.
